GUEST: Wichert Insurance Kevin Howell Kevin and Dale are here presenting their insurance quotes for Liability coverage for 2024. They have 2 quotes. One from EMC who we currently have and it was \$39,340.00. They also have a quote from Selective for \$33,915.00. Selective previously would not insure the Village due to the Dam at Reservoir. Mayor asked to extend our current coverage till the end of the month to give council time to review and decide.
